As there is no evidence of any previous planning history for the property it is considered that the property benefits from permitted development rights. The proposed rear flat roof dormer adds 21.3 cubic metres which is well below the volume constraint of 40 cubic metres for a semi detached property. The dormer is not located on the principal elevation fronting the highway; the flat roof dormer roof does not exceed the highest part of the roof, the property does not lie within a Conservation Area and all proposed materials will match the existing, therefore we consider the proposals to be acceptable under lawful development certificate.
