Officer noted that the principle of development in this area is accepted. No objection was raised to the area or layout in principal. The current proposals respond to some concerns regarding the layout of windows on the pre-application plans. Officer noted internal space and amenity space are above the minimum requirements. Officer requested a 45 degree line is drawn from the nearest window of no. 9 The Ridgeway, and this has been included in the drawings. Hard and soft landscaping details have been provided as requested by the officer. The WBC Ecologist noted in the letter that the proposal is unlikely to negatively affect bats.
