Shinfield Infant and Nursery School is situated at School Green, Shinfield, within the Wokingham Borough Council area. The application site is in a predominantly suburban location, south of Reading and west of Wokingham. To the north of the site is the School Green War Memorial Park, and directly to the north are two residential houses. Hyde End Road (B3349) road runs immediately south of the site in a southwest direction, with additional residential properties located further south. The existing school building is a Grade II Listed Building (the school and site forms) List Entry No: 1136149 (Historic England) with the site having undergone subsequent extensions and alterations since it was constructed.
