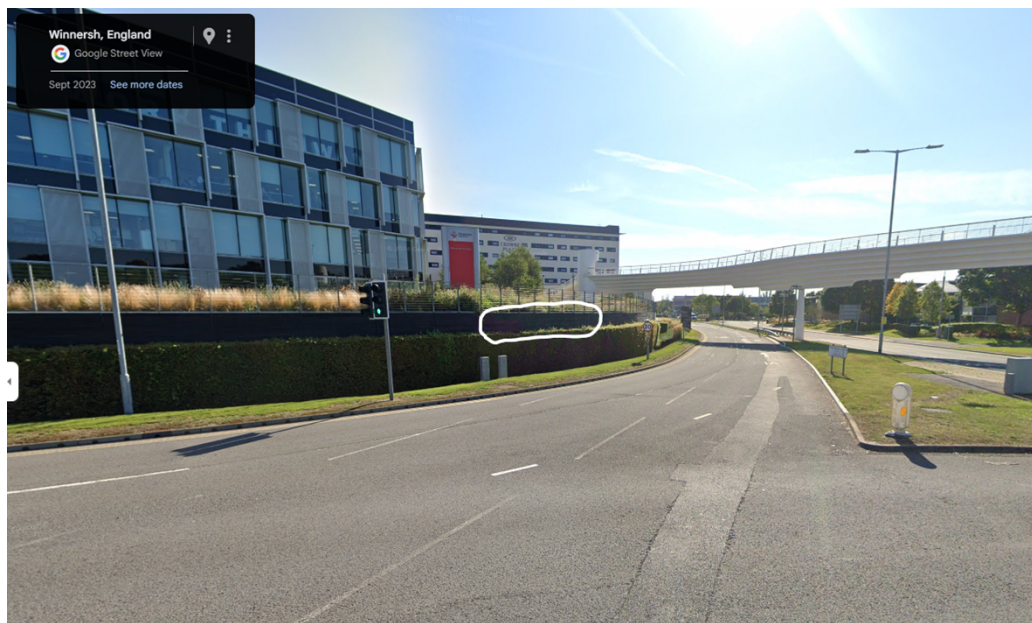

Comments On Proposal

The proposed illuminated signage is located on private land and does not affect the public highway.

From the information submitted it appears that the location of the lettering will be positioned on the boundary wall, once past the traffic signal head on the roundabout. In addition, the colour of light to be used on the lettering is stated as white, which would not be confused against traffic signal lights.



The level of luminance is stated as 400 cd/sqm. Due to the low level of luminance this is unlikely to cause glare or dazzle to road users. The lighting shall be static with no intermittent flashing or similar.

Conditions & Reasons (if required)

1. CV5 (AMEND) The illumination of the advertisement hereby permitted shall be non-intermittent and the light shall be white in colour. - NON-INTERMITTENT ILLUMINATION
2. CV6 (400) - LUMINANCE OF SIGNS
