The area in question has been used as an overflow car park for the past 15 years by the Countryside Service , due however to increases in usage from visitors the existing grass surface is inadequate during wetter conditions so an element of upgrade is proposed utilizing road plainings similar to elsewhere on the site.

This 100mm surfacing would enable over the 45m x 20m area would increase usability of the site without detrimentally damaging ground conditions or affecting visitors using it
