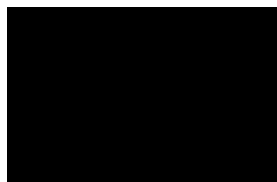
The Site Area is 4.89ha as set out in the numbered drawings above and as referenced in the Planning Statement. Please note some references to site area in other documents has been superseded.
