Comments On Proposal

General

The applicant proposes to install 6 no. EV charging upstands serving 10 parking bays. There is no net change in the total parking provision of the wider site. The site is in relation to another planning application 252014 of the wider site, for the replacement of existing warehouse building to a new commercial unit.

The proposed parking plan has extracted only the parking spaces with EVCP installed, so the proposed site plan of 252014 (Drawing No. 1010) is referred. The applicant is required to resubmit this drawing in this proposal.

Visibility Plays

The proposed positions of transformer, HV metering enclosure and the EV charging upstands have no negative impacts on sightlines and pedestrian visibility, which are acceptable.

Specifications of EVCP

The specifications of EVCP may subject to further authorisation via Building Control.

Summary

Subject to the proposed site plan (Drawing No. 1010 of 252014) being submitted, the Highways will have no objection to this proposal.

If there are substantial changes regarding the proposed positions of the EV charging upstands and/or associated structures, the Highways shall be reconsulted.
