- 5 x Oak Trees next to our house boundary that require significant trimming back
- All 5 Trees are overhanging the property boundary (especially over the house and touching the roof)
- There are numerous dead branches on these trees which urgently need cutting as they are falling off during heavy rain/wind and causing damage (images)
- There are photographs attached showing these 5 trees, the dead branches that are falling off and how much they overhang
- The overhang poses serious risk [REDACTED] and our property given the size of the branches that fall
- The roots of the tree next to the house are uplifting the driveway causing an obstruction to the opening and closing of the garage door (images)
- Attached is an Arboricultural Inspection report which was completed on 22nd November 2024 to support our request

Identification of Tree(s) and Description of Works

A full Arboricultural report is attached to provide clear specification of the works required, summary provided below.

- 5 x Oak trees on Clay Lane that are next to the property boundary
- Each one of these trees are significantly overhanging into the property boundary
- There are many dead branches that pose a risk to property and harm to us when in the garden

Works being requested:

- Trimming back of the branches that overhang into our boundary, reducing the risk of harm
- cutting off dead branches again to reduce the risk of harm

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.

- indicate the main features of the site where the tree(s) stand and its surroundings; in particular, you should:
 - mark and name surrounding roads
 - sketch in buildings, including adjoining properties
 - add house numbers or names
- mark the position of the tree(s) to which you want to carry out work and identify them by the number shown in the Tree Preservation Order where possible; if you use a different number, please make sure that this can be matched with your description of the tree(s)
- if there are many trees on the site, make clear which tree(s) are included in this application by:
 - marking all trees on the plan, but only numbering those to which you want to carry out work
 - showing the approximate distance between the application tree(s) and buildings
 - adding other relevant features on the site (e.g. greenhouse, paths)

If it is impossible to identify the tree(s) accurately on the plan (e.g. because they are part of a woodland or group of trees), please identify their approximate location on the plan and provide details of how the tree(s) are marked on site (e.g. high visibility tape, tree tags, paint, etc); trees must not be marked by scarring or cutting into the bark.
