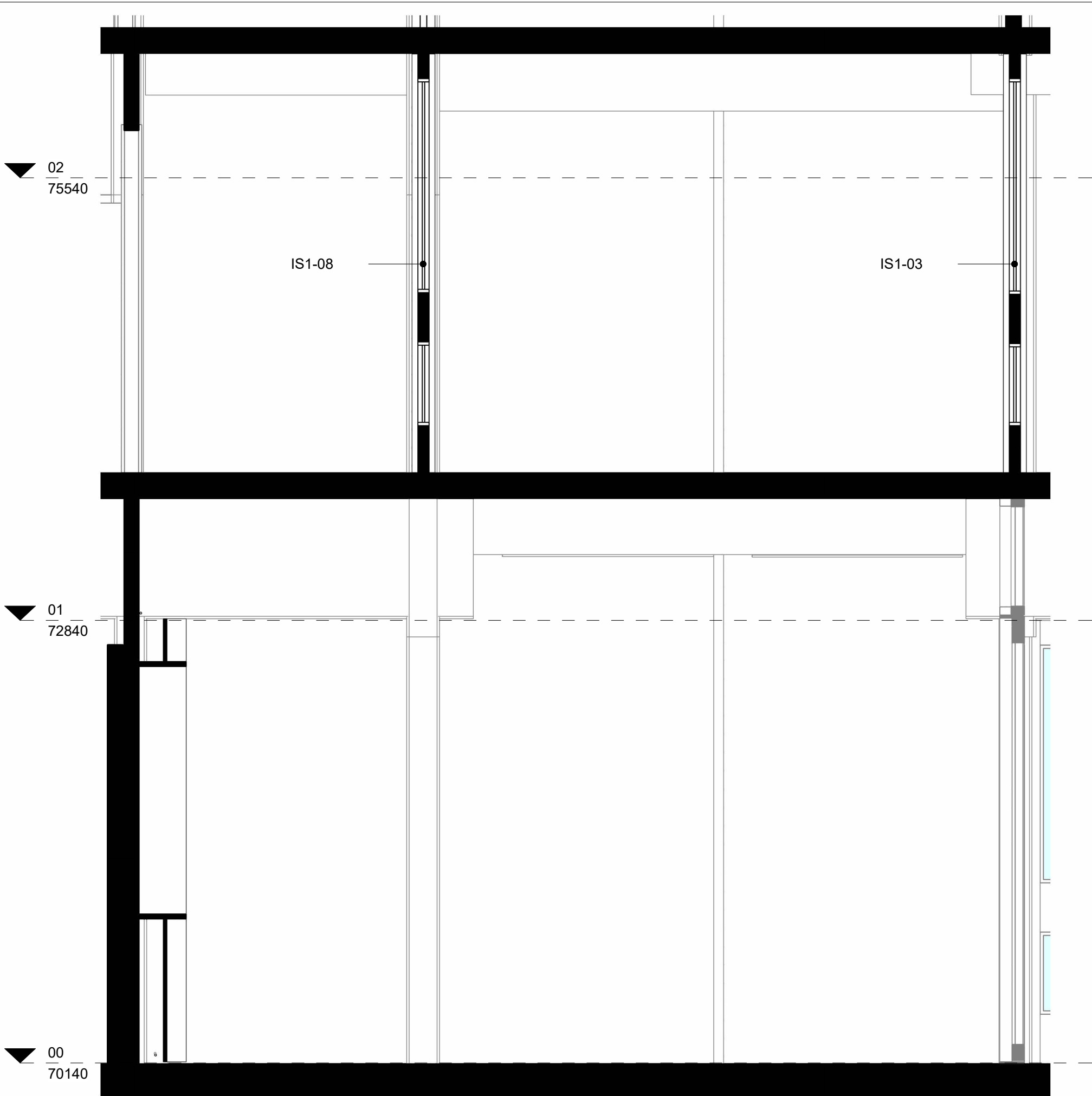
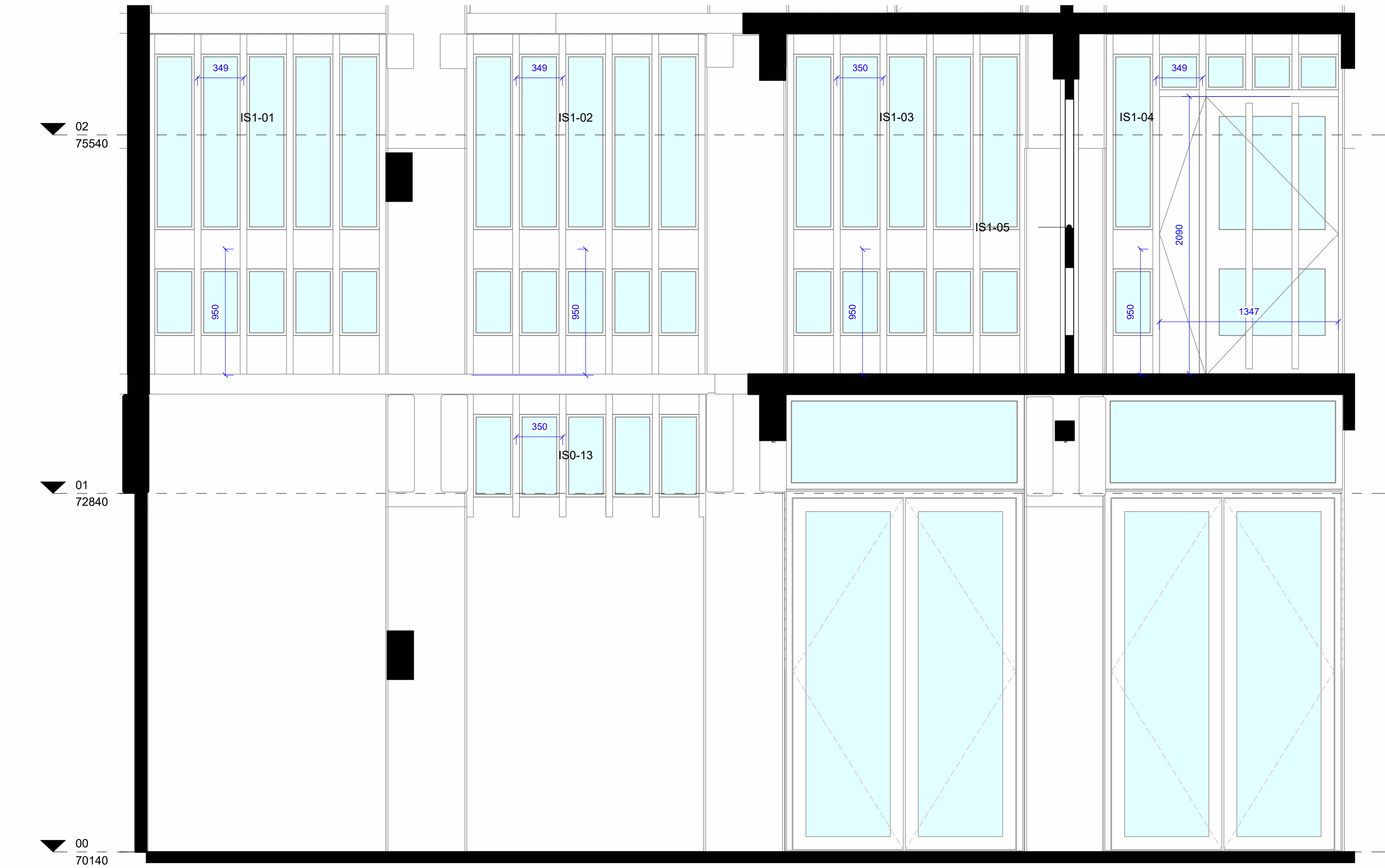


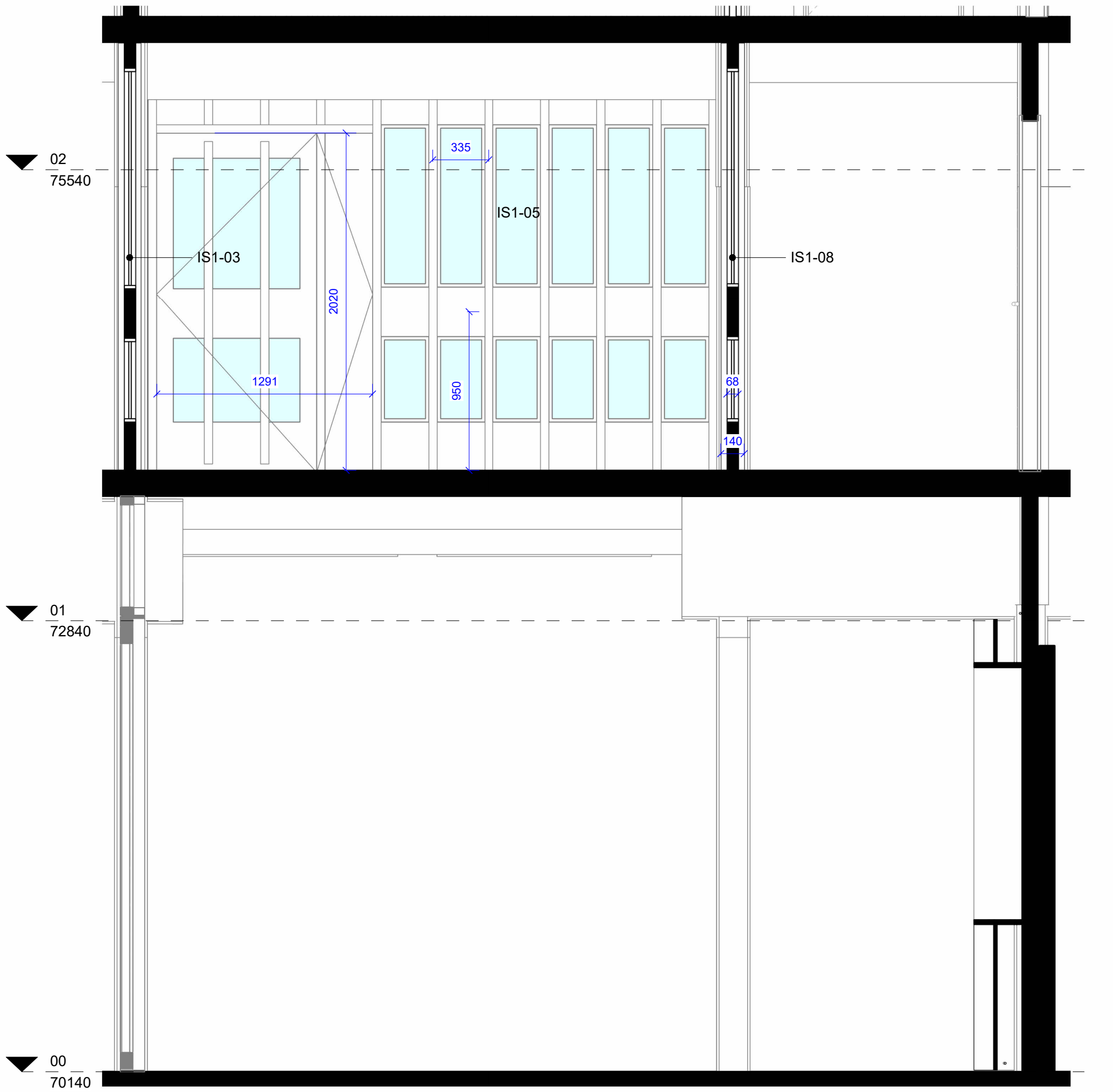
1 27056-Stair 1 Internal Screen Elevation - South

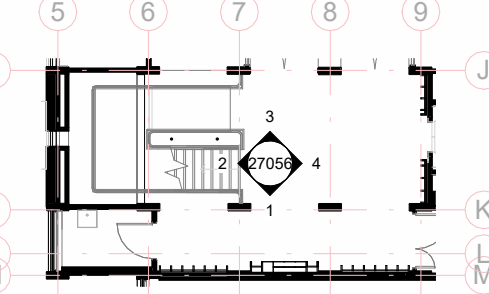
