Good morning Mr Crisp,

Thank you for the photos, which is most helpful.

I have further looked at this and sought advice, and the works that you have done are engineering works requiring planning permission. You will therefore need to submit an application for the works.

As the site is within a flood zone, and would be an issue when assessing the application, you will need to address this matter in your application with a flood risk assessment.

When we met you mentioned about shoring the edge of the land with the river. This is engineering works that would also require permission. You could put both works on one application.
