**SECTION 211 NOTIFICATION OF WORK TO TREES WITHIN THE TWYFORD  
CONSERVATION AREA**

**LOCATION: 16 LONDON ROAD, TWYFORD, WOKINGHAM, BERKS, RG10 9ER**

With reference to your notification which was received and validated on the 11 September 2025, I am writing to advise you that Wokingham Borough Council raises **no objections** to the proposed tree works being undertaken as specified within the Twyford Conservation Area.

**Proposed works:**

T3, Eucalyptus

- Crown reduction by 3m to 13m in height and 9m in spread.

**Officer comments:**


*Eucalyptus tree very close to property (Grade II listed building). it is almost double in height to the house. Canopy of tree overhangs part of roof and guttering, nearly touching chimney stack, which is in turn used for log burning stove. Foliage now also blocking light to main bedroom on first floor. Concern also that as tree is becoming excessively tall it could result in possible damage to house or neighbouring properties if ever felled in strong winds as happened previously to a eucalyptus tree in adjoining property at number 14 London Road.*

**Informatives:**

- 1) You are advised that, in accordance with Part 4, 17 (4) of The Town and Country Planning (Tree Preservation) (England) Regulations 2012, this decision is valid for **one pruning operation** (as per the approved specifications) to be undertaken **within two years** from the date of this notice, after which date the consent lapses and a new Section 211 Notification will be required.
- 2) You are advised that this letter is in respect of the **Conservation Area only** and it does not imply that consent would be forthcoming from the owner of the tree(s) or any such other persons from whom consent would be required.

Please note that your attention is drawn to the following information:

### **Bird Nesting Season and Presence of Bat Roosts**

In accordance with the Wildlife and Countryside Act (1981) and Countryside Rights of Way Act (2000), consideration must be given to the timing and type of tree work operations, to avoid causing disturbance to any nesting birds or bat roosts that may be present within the tree(s).

The Act makes it an offence (subject to exceptions) to intentionally kill, injure, or take, possess, or trade in any wild animal listed, and prohibits interference with places used for shelter or protection, or intentionally disturbing animals occupying such places.

It is advised that all non-urgent major tree work and hedge cutting operations are undertaken at a time to avoid disturbing nesting birds during the breeding season (to which the bird nesting season is considered to be from March to July). Where bats are suspected to be present, it is recommended that advice first be sought from a licenced bat specialist and if appropriate, the relevant licence(s) be obtained before any major tree work or hedge cutting commences.

### **Forestry Act 1967 and Felling Licences**

If it proposed to fell a tree or trees greater than 5 cubic metres or sell more than 2 cubic metres of timber in any calendar quarter, a Felling Licence from the Forestry Authority may be required.

Please note that Felling Licences are not required to remove trees from domestic (residential) gardens. Where you are the landowner of large pieces of land with numerous trees, clarification from the Forestry Commission may be required as to whether a Felling licence is needed.
