Currently there are two shipping containers sited at this location (previous planning application number 210961), planning permission has expired in June 2024, we are making a new application to site the two shipping containers at Pinewood on a permanent basis.

They are two standard 20ft wooden clad shipping containers (maximum size does not exceed 6560mm x 3090mm each, including cladding) for use by Wokingham Without Parish Council to securely store equipment belonging to the parish council or for use by Pinewood site tenants for storage of items primarily used at the Pinewood Site.

The containers are located on an existing concrete base at the Pinewood site (known henceforth as the "storage site"), adjacent to the Pinewood Gymnastics Club and behind the Judo Club building. This location is not visible from the main car park due to the existing buildings and existing foliage. The location is visible from certain areas within the woodland as such, the containers are clad in wooden cladding and blend in as much as possible with their surroundings.

One container is used for storage by East Berkshire Operatic Society (current Pinewood tenant). The second container is used to store equipment and items used by the parish council.
