## Comments On Proposal

**Drainage design drawing 0200 P03 dated 23/01/2025** indicates that favourable soakage rates could not be achieved and tanked permeable paving will provide attenuation for the 1 in 100-year flood event with a 40% allowance for climate change, with controlled discharge into a watercourse. The drainage calculations have not been provided. Please provide.

A package treatment plant manages foul drainage with discharges to the same point as surface water discharge. The combined discharge should be no more than the existing rates. Please provide that clarity.

We note that drainage maintenance will be carried out in accordance with **Infrastruct SuDS maintenance manual C-07.001B dated January 2025**.

Please provided the above-mentioned details for further assessment to discharge condition 6.
