## Comments On Proposal

### Condition 43 Construction Environmental Management Plan (CEMP)

1. This discharge of conditions application refers only to Parcels 4 and 5.
2. A CeMP (Document reference C86557-JNP-XX-XX-RP-G-1007 P02) has been submitted in support of this application which is welcome.
3. It is welcome that the hours of operation are in line with condition 44 of the outline approval. It is also welcome that the developer will apply to WBC if temporary changes need to be made to these hours.
4. It is welcome that parking for contractors will be contained within the site.
5. It is welcome that deliveries will be managed and wherever possible will be outside the AM and PM peak hours.
6. It is welcome that wheel washing and the monitoring of the highway including the use of road sweepers has been included.
7. The proposed gate will be set back from Sheerlands Road the length of the largest vehicle which is welcome.
8. All construction vehicles accessing and egressing the site will be managed by banksmen which is welcome.
9. It is welcome that the CeMP will be monitored and if there is a significant change then the CeMP will be resubmitted to WBC for approval which is welcome.

10. It is proposed that once the main contractor has been appointed a Construction Traffic Management Plan will be submitted to WBC for approval. Whilst that is welcome, highways would expect that Section 9 of this document includes information on construction routes to the site and details of off-site road signs with the caveat that these would be finalised when the main contractor is appointed.

11. If a satisfactory response to item 10 is submitted, then and only then would highways recommend discharge of this condition
