Details of the pre-application advice received

It is anticipated that only full planning applications would be required for the barn. Overall, the proposal represents a scheme that could be sensitive to both built heritage on the [farm] and the surrounding countryside. Whilst the proposal does not comply with the exceptions of development in the countryside under policy CP11, the scheme would unlikely conflict with the overarching aims of that policy, and...would likely maintain the quality of the environment. From a heritage stance there is no objection to this structure being demolished and likewise for its replacement by the proposed small pitch-roofed barn structure. In terms of the new barn, the design is as to be expected for a building with a functional role. The proposed materials indicated (timber cladding, brick plinth and pitched clay tiled roof) would appear to be appropriate
