Please describe the proposed works

We are planning to remove the existing 10-11ft tall hedge from the right hand side of our property, adjacent to Duffield Road and replace it with a wooden fence with concrete posts behind the existing brick wall. The hedge is overgrown and needs to be cut back, however, it is dead and so we will need to remove it completely and replace with the aforementioned fence. As our main garden area is to the right of our property, the hedge gives us privacy from the road and footpath, and therefore we want to erect a fence of a similar height. The standard 3.3ft fence would mean that anyone walking/driving past can see into our garden and we will have no privacy. Numerous other properties on Duffield Road have erected 2m-3m high fences adjacent to the road, so there is precedence.
