







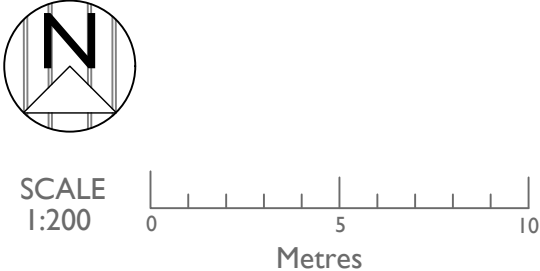

Heuchera 'Fire Chief'	2L	18	Rich red foliage; ties to brick colour; excellent all-year structure
Helichrysum 'Icicles'	2L	18	Bright silver trailing foliage; ideal for edges and contrast
Senecio (Brachyglottis) 'Sunshine'	3-5L	16	Silver foliage, evergreen, architectural; complements grey joinery & red brick

Amelanchier lamarckii 'Juneberry'	1.5-2m Tall	1	Light canopy tree, excellent seasonal interest.
Acer campestre 'Elsrijk'	2.5-3m Tall	1	Pollution-tolerant, upright shape.
